Terms and Conditions for Marketer Members

1. I understand that my Application has to be approved by coop admin prior to acceptance and that upon acceptance, I will be notified.
2. I understand that upon acceptance, the Marketer Registration Fee must be paid to the account of the cooperative.
3. Any deferment of fees shall be entered as a loan .
4. Any sales income earned shall firstly be allocated to pay off any outstanding loan.
5. I understand that as a Marketer the following fees shall apply.

Marketer Establishment Fee R 1250,00 allocated for training and admin of Marketers
Marketer Registration FeeR 250,00 for members who want to be marketers
Coop Annual Subscription Fee R 250.00
6. I understand that I do not REPRESENT the Cooperative in any activity except by the express written permission of the Cooperative, and that my marketing / Sales activities are that of an INDEPENDENT MARKETER in my personal capacity.
7. I understand that I may not make any income claims or asset appreciation projections or claims other than those authorized by the Cooperative.
8. I understand that I am responsible for the payment of my own income tax and that any income earned by way of my sales activities forms part of my personal tax liability within my OWN business as an INDEPENDENT MARKETER.
9. Any marketing materials, literature, website information, or social media content and the like, must be authorized by the coop PRIOR to publication, display, or presentation.
10. I understand that the Cooperative has the right to terminate my marketing activities as a consequence of any unacceptable conduct that may reflect negatively on the Cooperative.
11. In the event of such termination the following shall apply:-
 - a. All marketing activities shall cease immediately.
 - b. Any subsequent referrals that arise after the date of termination shall be re-allocated by the Cooperative at its sole discretion.
 - c. Termination of marketing shall not affect member shareholding and distribution of income from property sales or rentals.
 - d. A terminated marketer may still increase its shareholding provided it is still a coop member
 - e. Marketing activity may be restored after a minimum period of six months, subject to the approval of the Cooperative management and the payment of a new Marketer Registration Fee.
12. Cessation of marketing activities may take place at any time by choice of the member.
13. I understand that my Marketer status is based on a shared interest and common objective with that of the Cooperative Mission Statement and hereby acknowledge my responsibility in upholding those values.
